## OKLAHOMA HOSA REQUIREMENTS FOR STAR CHAPTER AWARDS

### Footnotes

1. Industry judges must be healthcare professionals and may not be chapter advisors or event coaches.

2. Judges must be onsite and approved by Oklahoma HOSA.

3. Activities should include leadership development, professional development, community service, and social engagement. (Program of Work)

4. Camp IGNITE attendance refers to the previous program year.

A few important highlights and reminders:

## *Diamond Chapter Recognition*

The Platinum Star Chapter with the highest donation to NMDP will be recognized as the Diamond Chapter and will receive a special award at the State Leadership Conference (SLC). This continues to be a meaningful way to celebrate exceptional service and impact.

## *Camp IGNITE – Gold Chapter Update*

You'll notice a new requirement for Gold Star Chapters requiring member and advisor attendance at Camp IGNITE. Because this requirement is based on attendance from the previous program year, it will be waived for Gold chapters this year only.

-This requirement will be fully enforced next year, so please plan accordingly.

## *Important Clarification: Recording Volunteer Hours & NMDP Donations*

We know there has been some confusion, so please note the following important clarification—new this year:

- ALL NMDP volunteer hours must be recorded in the NMDP Volunteer Portal — NOT in HATS
- HATS (HOSA Activity Tracking System at [hosa.org](http://hosa.org)) is used ONLY for:
  - Barbara James Community Service hours
  - American Red Cross hours
  - Health Literacy Ambassador entries

Recording hours in the correct system is essential to ensure chapters receive proper credit and remain eligible for recognition.

## *Competitive Events Update Coming Soon*

When we return from Winter Break, I will be providing a Competitive Events Update that will include information on new events and changes to existing events for this year. I'm excited to share that Oklahoma WILL be piloting a new competitive event this year:

Physician Assistant – Medical Case Challenge (*guidelines attached*). Even more exciting — the state-winning team in this pilot event will be given the opportunity to showcase the event in a special demonstration at the International Leadership Conference (ILC). This is a unique opportunity for Oklahoma students to help highlight and shape a new national event.

Thank you for all you've poured into your chapters this year. I hope the upcoming break provides space to rest, reconnect, and recharge as we prepare for an exciting and impactful spring with Oklahoma HOSA.
